## Conference Registration Scholarships

- **January**—Municipal Service Providers pledge to offer one or more conference registration scholarships & MTAW will invoice the Providers
- **February**—Scholarship application, which includes Providers’ names & scholarships, is posted on MTAW website and Facebook page—Members submit applications by the March 1 deadline
- **March**—Scholarship Committee reviews applications & recommends recipients at the Spring MTAW Executive Board meeting
- **Spring Conference**—Providers & recipients are announced at the Annual Meeting
- **Spring Conference**—Providers display scholarship pledge at their vendor display
- **May**—Providers & recipients are posted on the MTAW website & Facebook page
- **Fall or Next Spring Conference**—Recipients may use scholarships for the upcoming Fall Conference or next year’s Spring Conference—Scholarships are made as a reimbursement to the recipient’s municipality
- One scholarship per MTAW member per lifetime
- Current Executive Board members are ineligible for conference registration scholarships
